

**ORDINANCE NO. 2020-006**

**AN ORDINANCE WAIVING COMPETITIVE BIDDING  
FOR PURCHASE OF 2022 FORD F250 PICKUP THROUGH  
STATE PURCHASING PROGRAM FOR USE BY STREET DEPARTMENT**

Whereas, the City is in need of a replacement pickup for use by the Street Department;

Whereas, a suitable vehicle has been located at Magie Ford at the best price reasonably obtainable, through the State purchasing program; and

Whereas, as such vehicle is urgently needed, and such vehicles are extremely scarce at present, so it is necessary to waive competitive bidding and purchase such vehicle.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYRONZA, ARKANSAS, AS FOLLOWS:

1. That the City has located a new 2022 Ford F250 two wheel drive Pickup with bedliner and steps at a price not to exceed Twenty-Six Thousand and No/100 Dollars (\$26,000.00), and as such is the best price reasonably obtainable, and since such vehicles are extremely scarce at present, competitive bidding is not feasible or practical, and the requirement of competitive bidding is waived.

2. That the Mayor and Recorder/Treasurer shall be, and hereby are authorized to enter into a contract for, and to accomplish the purchase of such vehicle for the sum of not more than Twenty-Six Thousand and No/100 Dollars (\$26,000.00).

3. That as the aforementioned vehicle is urgently needed as a replacement vehicle for use by the Street Department, and as it is necessary for the preservation of the public peace, health and safety, an emergency is declared to exist, and this Ordinance shall be in full force and effect from and after its passage.

**ORDINANCE NO. 2021-005**

**AN ORDINANCE AMENDING ORDINANCES NOS. 1998-6 AND 2015-003 TO PERMIT A LIMITED NUMBER OF CERTAIN ANIMALS TO BE KEPT WITHIN THE CITY BY EAST POINSETT COUNTY SCHOOL DISTRICT STUDENTS PARTICIPATING IN 4-H OR OTHER SCHOOL SPONSORED AND SUPERVISED PROGRAMS**

WHEREAS, it is important for students in the East Poinsett County School District to be able to participate at 4-H and other school sponsored and supervised programs concerning the proper care and exhibition of farm animals; and

WHEREAS, it is desirable to amend existing ordinances to permit the care of a limited number of such animals within the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYRONZA, ARKANSAS, AS FOLLOWS:

Section 1. That Ordinances Nos. 1998-6 and 2015-003 shall be, and hereby are, amended to permit East Poinsett County School District students participating in the 4-H program or other school sponsored and supervised activity regarding farm animals to keep one sheep and one goat, or two goats, without weight limit, or up to four rabbits, or up to twelve chickens, but no roosters (male chickens of more than six months of age), at the student's residence, subject to the requirements of keeping such animals within an adequate, secure, humane, and sanitary enclosure in the backyard of the residence, not less than fifteen feet from any property line, which shall be cleaned not less than on a weekly basis, and otherwise complying with all state and local laws and regulations, including any requirement of purchase of a building permit for such enclosure.

Section 2. That this ordinance shall amend Ordinance Nos. 1998-6 and 2015-003, and it shall supersede Ordinance No. 2019-02.

Section 3. That as this ordinance is necessary for the preservation of the public peace, health, and safety due to sanitary and other concerns, an emergency is declared to exist, and this ordinance shall be in full force and effect from and after its passage and adoption.


